EMIT highlights these criminal justice reform bills pending in Massachusetts:

Restorative Justice – (S 71 Eldridge) (H 1313 Garbally) To provide an opportunity for offenders of all ages to repair the harm caused by the event, as opposed to adjudication, punishment and incarceration.

Expungement – (S 810 Eldridge) (H 1248)

To permanently erase from public record: certain offenses made by juveniles and young adults; and false and mistaken accusations made against adults who have been exonerated.

Increase Felony Larceny – (S 2132 Eldridge)

To raise a felony offense from \$250 to \$1300 to prevent creating a felony record and incarcerating people for minor crimes. We are one of a few states with such a low felony trigger. This bill has been reported favorably out of the Judiciary Committee.

Solitary confinement – (S 1255 Eldridge) (H 1475 Malia) To ensure appropriate use of segregation in prisons and jails that will also reduce recidivism, curb unnecessary spending and increase safety and security in prisons.
